Dear Representative Herrera Beutler and Representative Nadler:

On behalf of the American Society of Transplant Surgeons (ASTS), our members, and the patients we serve, thank you for introducing the “Living Donor Protection Act of 2017.” We greatly appreciate you advancing this bipartisan legislation which would remove certain barriers to life-saving transplantations by safeguarding the rights of organ donors.

Established in 1974, ASTS serves approximately 1,800 surgeons, physicians, scientists, advanced transplant providers, and other transplant professionals dedicated to excellence in transplantation surgery. Our mission is to advance the art and science of transplant surgery through leadership, advocacy, education, and training. ASTS advocates for comprehensive and innovative solutions to meet the needs of ASTS members and their patients.

We are pleased to share our strong support for the “Living Donor Protection Act of 2017.” There is a significant demand for transplantation as the national waiting list for donor organs continues to grow, with more than 118,000 patients on the waiting list, 22 of whom die each day. The “Living Donor Protection Act of 2017” would address the growing demand for transplantation by protecting organ donors from discrimination, maintaining job security for organ donors, and educating Americans on certain rights of organ donors. Specifically, the passage of this legislation would prohibit insurance companies from declining or limiting coverage or increasing the premium rate for coverage of a person under a life, disability, or long-term care insurance policy due to a person’s living organ donor status. The legislation would also provide job security to donors by clarifying that donors may use Family and Medical Leave Act of 1993 (“FMLA”) time to recover from organ donation surgery. Lastly, the legislation directs the Secretary of Health and Human Services to update educational materials on the benefits of organ donation and the impact of organ donation on the access to insurance.
