## **American Society of Transplant Surgeons Disclosure Policy**

It is the policy of ASTS that individuals in a position to influence/control content of a CME activity disclose all or apparent conflicts of interest(s). ASTS committee members, faculty, staff and other individuals involved in the planning of a CME activity are required to disclose to learners relevant financial relationship(s) that have occurred within the last 12 months of the activity with any commercial interest(s) whose products or services are discussed in the CME content. Financial relationships are those relationships in which the individual benefits by receiving a salary, royalty, intellectual property rights, consulting fee, honoraria, ownership interest (e.g., stocks, stock options or other ownership interest,), or other financial benefit. Financial benefits are associated with roles such as employment, management position, independent contractor (including contracted research), consulting, speaking and teaching, membership on advisory committees or review panels, board membership, and other activities for which remuneration is received or expected. ACCME considers relationships of the person involved in the CME activity to include financial relationships of a spouse or partner. If there are no relevant financial disclosures, the learners must be informed that there are no relevant financial disclosures or he/she has nothing to disclose.

The intent of this disclosure is not to prevent faculty with relevant financial relationships from planning or delivery of content, but rather to provide learners with information that allows them to make their own judgments. It remains for learners to determine whether financial interests or relationships may influence the activity. All relevant potential conflicts of interest that are identified and are vetted through a process that includes appropriate peer review by the CME committee liaison, and/or chairs or co-chair for fair balance, scientific objectivity and validity, patient care and safety recommendations.

Because the review, identification, and resolution process must take place prior to the activity, all disclosure information must be submitted by the stated due date in order to ensure participation. Failure to disclose within the necessary timeframe will result in disqualification to participate.

## Unlabeled/Unapproved use of drugs:

ASTS requires that all faculty presenters disclose their intent to discuss any unlabeled/unapproved uses of drugs and/or devices during their presentations.

## **Conflict of Interest Resolution process**

A conflict of interest (COI) is present when a planner, faculty speaker or author has **both** a current financial relationship with a commercial interest **and** the opportunity to affect content relevant to products or services of that commercial interest. If it is determine that planners, presenters or authors have financial relationships that create conflict of interest, the COI will be resolved before the activity. The COI review will be conducted by peer-review by the CME Committee Liaison, Chair, Co-chairs, and/or faculty member who does not have a conflict of interest to review the program for balance and absence of bias.
